Area Automobile Break-ins

At the Annual Meeting Aurora Community Police Officers **Ron Miller** and **Kyle Hoffman** addressed the issue of automobile break-ins



occurring in Aurora — particularly on the West Side and specifically in the Orchard Valley subdivision. Both officers suggested that homeowners do due diligence by reporting any suspicious behavior in the neighborhood — strangers/individuals roaming through the subdivision, particularly at dusk or nighttime. Whenever possible, park your vehicles in your *locked* garage. If you must leave your vehicle outside (*particularly overnight*), be sure to remove all valuables from sight and ensure that your vehicle's windows are closed and the doors are *locked*. In recent news broadcasts it appears that Aurora is not the only community seeing an increase in these occurrences of automobile break-ins. Naperville and Buffalo Grove have also been experiencing a rash of car break-ins. One last suggestion — *keep your outdoor lights on, thieves like to work in the dark!* Remember, *an ounce of prevention is worth a pound of cure!!!*

OVHA ANNUAL ELECTION RESULTS!!!

The Association's Annual Meeting and election was held on June 16, 2016 at St. Davids Church. President Jason Morthland convened the meeting at approximately 7:15 p.m. with the introduction of Aurora Community Police Officers **Ron Miller** and **Kyle Hoffman**. Following a brief question and answer session, President Morthland introduced a special guest — **Carl Franco, 5th Ward Alderman**. Alderman Franco's comments touched upon several on-going projects in the community.



A review of the Minutes from the 2015 Annual Meeting followed the evening's special guests. Upon acceptance of the minutes, the Board moved to the Annual Election process. Candidates that were present introduced themselves to the audience. Nominations for the Board were then sought from the floor. Upon completion of this phase, the ballots were collected and handed to the Association's Property Manager, Pat Torres, for tabulation; two members of the audience volunteered to assist in counting the ballots. Following a short homeowner session, Pat Torres presented the Board with the election tabulations — **top three** are elected. The voting produced the following results:

George Dyche — 71 (*Elected to a 2 year term*)
Mark Plummer — 60 (*Elected to a 2 year term*)
Harold Borg — 56 (*Elected to a 2 year term*)
Jim Sokolowski — 39

ARC Submittals

If one intends to make changes to the exterior structure or landscaping of their OV property, please be reminded that *prior* approval from the Board is required. The appropriate *required* documents may be found at our website — OVHA.org. Please download, print and complete the requisite documents. In certain cases one may be required to obtain a building permit from the City of Aurora. All necessary documents need to be completed and submitted *directly* to Alpha Management, *not* to individual Board members.

Members of the OVHA who intend to sell their home and relocate outside Orchard Valley are reminded that part of the *closing cost*

fees they shall incur at the closing includes a *disclosure statement* as well as the *final inspection letter* provided by Alpha Management. ❖❖❖

Watering Restrictions

Lawn-watering is restricted to the hours of 6:00-9:00 a.m. and 6:00-9:00 p.m. on “*odd and even*” day protocol (*based upon the last digit of one’s home address*)

Homes with permanently installed sprinkler systems shall follow the same schedule.

Watering is prohibited on both July 31st as August 31st for all residents. (2013 Aurora Water Conservation Ordinance)
