Dear Resident or Small Business Owner:

The City of Aurora (City) offers an Electric Aggregation Program at no added cost to the ComEd rate.

The City is currently contracted with MC Squared Energy Services, LLC (mc²). mc² will provide eligible residents and small businesses with electric supply <u>pricing equal to the monthly ComEd published tariff supply rate</u> during the remaining thirteen (13) month term of the electric aggregation program through December of 2025. This Electric Aggregation Program provides us with a civic contribution for community initiatives at zero added cost to residents and the City. There is no additional cost to you to participate in this program.

You are not required to do anything to participate in the City's Electric Aggregation Program.

mc² will automatically process your enrollment and you will pay the same rate as the published monthly ComEd rate. There are no enrollment or early termination fees. If you are currently participating in a community solar savings program, or will be in the future, this municipal electricity aggregation supply program will not impact your community solar program. The community solar generation credits provided by ComEd are independent of this aggregation program.
